#### **Proposal for Consulting Services**

Matt/Angie:

This proposal is intended to capture our phone conversation exploring options to assist Green Mountain Falls through the upcoming Town Clerk transition.

While I am not available to assist in any sort of regular on-site capacity, we spoke about specific tasks that I may be able to offer services toward. This proposal is intended to be an example of what those services may be and is not an inclusive list.

#### Examples of Services:

- Election options:
  - Provide full-service consulting for the DEO toward carrying out the regular April 2022 election.
  - Serve as DEO for the said election.
  - Provide hourly as-needed consulting to advise staff when requested.
- Specifically-requested needs, such as licensing review/processing.
- Assistance with Clerk recruitment/selection.
- Focused training for newly hired Clerk. We would identify the new Clerk's existing skill set and address skill gaps through focused individual training and/or a long term training plan that includes available training from the Colorado Municipal Clerks Association and other professional organizations.

#### **Pricing:**

Services can be priced as a lump sum for the entirety of the project, by the day, or by the hour, at the Town's discretion. For a known project, such as an election, a lump sum gives the Town a known price that is all-inclusive as a known bottom line cost. No additional travel or incidental costs are charged.

The daily rate would apply for on-site services of 6 hours or more, and can be pro-rated for days shorter than that. This would be the most appropriate type of fee for services such as training. Again, this daily rate is all-inclusive.

Hourly services may be more appropriate when advice is requested and the amount of time investment is less predictable, such as managing the process for a liquor license; or for any service that can be done remotely. Any contract may be written to represent both options and the choice will be at the discretion of the Town.

Lump sum for election consulting, either as advisory to the DEO or acting as DEO:

- \$5,000 for a mail ballot election with candidates, ballot questions, and no TABOR issues.
- \$6,000 for a mail ballot election with TABOR issue(s)
- \$8,000 for a polling place election without TABOR
- \$9,000 for a polling place election with TABOR

Note that my regular price for election services is \$7,000 to \$10,000. Because GMF is a past customer I am holding my prices to the prior level.

I have provided a sample Scope of Services for an election contract. This can be customized to meet your needs once you're ready to enter into a contract.

Daily rate for on-site services is \$600/day, which is discounted from my regular price of \$700/day. This is an all-inclusive rate with no charges for travel or incidentals.

Hourly rate for off-site services is \$70/hour. Note that this is discounted from my regular rate of \$80/hour.

#### About me:

I know that many folks in GMF know me from my prior work there, but I have included my resume and a customer list that you are welcome to share with anyone as you desire.

#### Sample Scope of Services for Regular Election

Consultant will:

- Establish the election calendar and ensure that all deadlines are met.
- Create and provide written procedures to direct Town staff in carrying out day-to-day election customer service activities. This will be provided in a comprehensive election manual that can be used as a resource for both staff and judges.
- Provide candidate information and petition forms, including FCPA forms and schedule.
- Assist in creating and conduct training for potential candidates, if requested.
- Provide a ballot security plan that Town Staff will implement.
- Create or review all forms, signs, and notices necessary.
- Work with Town staff in developing the ballot format and securing printing services.
- Assist the Clerk in compiling Pro-Con statements and summaries (if applicable)
- Direct or facilitate mailing of the TABOR notice (if applicable)
  - Note that Town staff will be responsible for determining all financial information.
- Create materials for Judges' Training and conduct the on-site training.
- Ensure that all follow-up actions are carried out after the election.
- Be on-site:
  - For an initial visit to determine physical location needs and ballot security plan.
  - To train election judges
- Because I often have multiple contracts for the same election day, my commitment is to be available by phone/text/email the entirety of the day. Depending on geographical limitations, I may or may not be able to be on site but will if possible.

The Town would commit to:

- Commit the Clerk as the point of contact. The Town Board remains the final authority and may designate other person(s) as desired.
- Commit the Clerk and/or other Town staff to carry out on-site voter assistance needs such as issuing replacement ballots and looking up voter registrations.
- Purchase all necessary election supplies as determined by Consultant.
- Facilitate and pay for all necessary printing and postage costs.
- Provide legal counsel for all legal advice needs.
- Recruit and appoint suitable Election Judges, in a number mutually determined by the Town and Consultant
- Pay the Election Judges directly.

At the August 24, 2021 special meeting of the Board of Trustees, the Trustees requested staff provide information on the following items regarding their consideration of the proposed Fitness Court donation.

- CIRSA Liability Insurance Costs
- Pit Toilet Options for installation at Tennis Court Park
- Cost of Internet May through September
- Letter to residents near Pool & Tennis Court Park that may be impacted by the Fitness Court installation.

Staff followed up on each of these items, and the status is as follows.

- The project will add \$319 to our 2022 CIRSA insurance premium annually.
- Pit toilet installation will run between \$60k and \$70k approximately.
- Staff is waiting on a quote for the cost of year-round internet and a signal booster from our vendor. The estimated cost of internet at the pool is approximately \$90 per month. It would be an annual contract term 1-3 years. We will not need a booster or any special equipment beyond the normal. Our vendor will utilize an outdoor AP or an antenna at no extra cost.
- On September 1, 20221, a letter along with information regarding the Fitness Court was hand delivered to 20 residents whose properties are around or near the park. A copy of the letter and Fitness Court information residents received is included in this packet.

#### Keith Haring Fitness Court Project

Chris Keesee, representing the Kirkpatrick Family Fund, brought to the Towns attention the opportunity to own a fitness court that would also display the work of the artist Keith Haring. The proposed location for the fitness court would be adjacent to the other recreational facilities in Pool Park. See attached documents for details about the court and the proposed location.

The Kirkpatrick Family Fund would make a grant to the Town of Green Mountain Falls to acquire the fitness court for the amount of \$200,000 which would cover the purchase price of the fitness court, installation and a five-year license for the Keith Haring Artwork. The Kirkpatrick Family Fund would be responsible for the selection and cost related to future art and applicable licenses for a subsequent period of twenty years.

The Kirkpatrick Family Fund would require a memo of understanding outlining the town's responsibilities/commitment in the acquisition, installation, and operation of the fitness court. The Town of Green Mountain Falls would agree to provide the following supports for the fitness court:

- a. Year round, daily access to restroom facilities in the park
- b. Wi-Fi internet to access the app and any supplemental training information for the fitness court
- c. A schedule for monitoring the fitness court equipment for maintenance and safety

d. Provide a plan to the Kirkpatrick Family Fund to manage ongoing upkeep and maintenance of the park plus priorities for future improvements of Pool Park grounds and recreation facilities. This is to include information on the restrooms, and upgrades to the park shown in the attached diagram.

e. Confirm that the park is ADA compliant

f. Secure \$20,000 in funding to install the concrete pad required for the fitness court

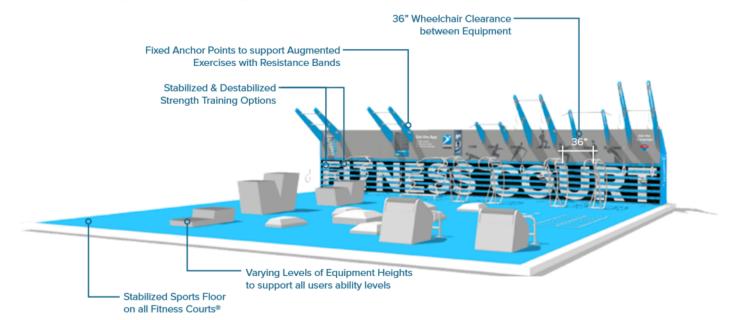
The Parks, Recreation, and Trails Committee is recommending to the BOT to conditionally approve HGMFF's acquisition and installation of the Fitness Court at Pool Park on the conditions that the Town enter a memorandum of understanding with HGMFF and also address and confirm complete bullet points a through f of this memo.

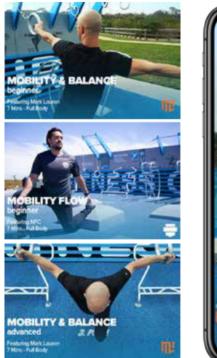

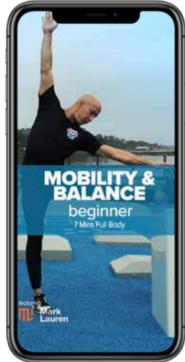

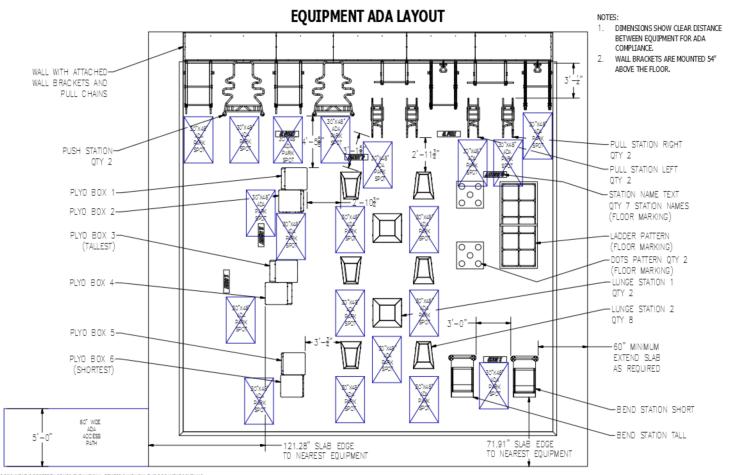

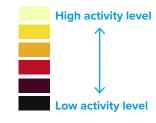

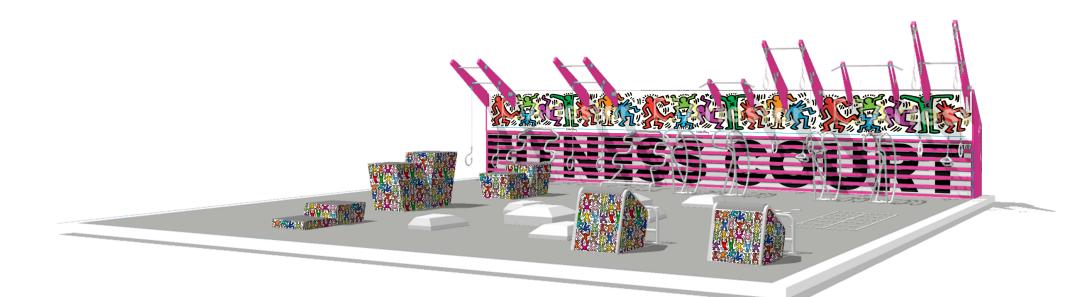

#### PROPOSED DEMOLITION + NEW CONSTRUCTION + RENOVATION DIAGRAM

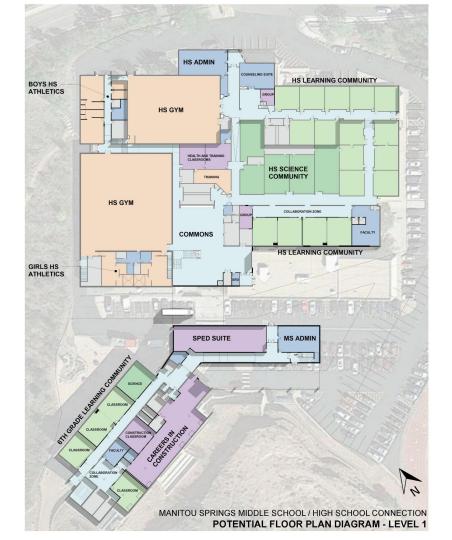

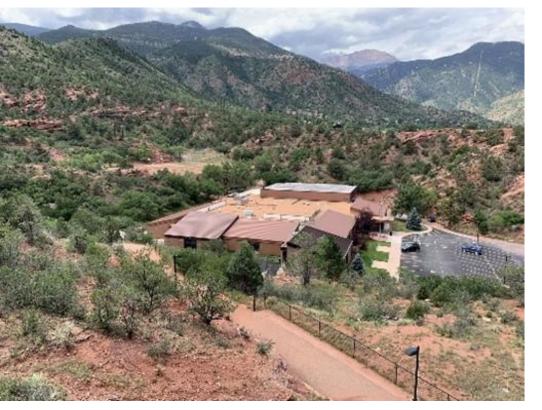

## APRA Use of Funds

The Coronavirus State and Local Fiscal Recovery Funds provide eligible state, local, territorial, and Tribal governments with a substantial infusion of resources to meet pandemic response needs and rebuild a stronger, and more equitable economy as the country recovers. Recipients may use these funds to:

- Support public health expenditures, by, for example, funding COVID-19 mitigation efforts, medical expenses, behavioral healthcare, and certain public health and safety staff
- Address negative economic impacts caused by the public health emergency, including economic harms to workers, households, small businesses, impacted industries, and the public sector
- Replace lost public sector revenue, using this funding to provide government services to the extent of the reduction in revenue experienced due to the pandemic
- Provide premium pay for essential workers, offering additional support to those who have and will bear the greatest health risks because of their service in critical infrastructure sectors
- Invest in water, sewer, and broadband infrastructure, making necessary investments to improve access to clean drinking water, support vital wastewater and stormwater infrastructure, and to expand access to broadband internet

Within these overall categories, recipients have broad flexibility to decide how best to use this funding to meet the needs of their communities.

## American Rescue Plan Act (ARPA)

Green Mountain Falls was founded in 1890, is located within the rapidly growing Colo Springs urbanized area, but situated in a deep valley at the foot of Pikes Peak, there is a major creek running nearby - Fountain Creek which is part of the regional Fountain Creek watershed. GMF is surrounded by heavily wooded areas, prone to wildfire risks and subsequent flooding, Waldo Canyon fire took place nearby, and we have a heavily traveled portion of state highway US 24 running alongside the town. All these reasons contribute to use, increasing our need for a safe accessible roadway system for our residents and visitors, which has long been a series of unimproved roadways. The road system in the Town of Green Mountain Falls is gravel surfaced in all the residential areas of town, and stormwater runoff is conveyed wholly by the roads downstream to discharge into drainage ways tributary to Catamount Creek, or Fountain Creek via the Gazebo Lake. Roadside ditches are in disrepair or non-existent and lack definition where they are present. Pipe culverts that exist are not properly sized to accommodate capacities of runoff impacting the roads and need to be upsized, and many locations require the addition of or new culverts. Long-term road maintenance has been sporadic and not adequate to repair the roads and bring them to a final condition after storms, that could be sustainable. The extent of erosion caused by storms results in roads being impassable at times. There are several roads that have concrete swales or ditches that were installed long ago. These unfortunately don't work in gravel roads, as gravel roads are not stable and change with the weather too much for these to be a dependable ditch. With recent storm runoff, the grades resulted in the streams choosing a different course. Those concrete ditches should be removed and replaced and grading in actual roadside ditches on one or both sides, depending on runoff. There is a need to essentially re-grade the roadside ditches for almost all the roads. These roads likely will never be paved, so there won't ever be a concrete curb and gutter and inlet/storm drain system for drainage. So, maintaining the ditches, that is cleaning out sediment and reshaping especially after storms, is what the Town should be prepared to be doing regularly. That and grading a good crown in the road so the water sheets off the road rather than running down the road and creating more erosion rills.

#### D. DEMONSTRATION OF NEED

#### a. Demonstration of need

Why is the project needed at this time? (2,500 character limit)

Road improvements were identified in our 2019 Comprehensive Plan as the number one priority and concern of our residents. Road improvements going forward are of key importance for the safety of town residents, especially given the potential for natural hazards (fires, floods, etc.) which highlight the need for safe passage/circulation. We also are surrounded by water assets that are part of the Fountain Creek watershed. Colorado Springs Utilities has a large water asset located on Catamount Mountain/Reservoir that provides clean water for residents in the entire region. Without a healthy roads system in Green Mountain Falls, those assets will become inaccessible. Further, when access to homes is impacted there is extortionary community and staff concern about the health, safety, and wellbeing of our residents and visitors. The road and drainage plan you would be funding is necessary to provide contractors and maintenance staff a plan for providing immediate repairs to many of the roads, and as a future reference for continued regular road maintenance. Gravel roads require almost constant maintenance which requires obtaining new material. A plan for the roads will include information on material quantities for replacement of road base. Without a plan for addressing the unique geometric and material needs of each road, the effort to maintain these roads will continue to result in lack of efficiency of road maintenance resulting in wasting the Town's resources. . At larger risk to all is the impact to emergency vehicles and first responders when roads are in great disrepair. Implementation of the above-described plan, combined with provision of competent personnel and critical equipment, will result in a long-term reduction in spending on expensive contracted road "projects." A single project to repair a short stretch of road has often been costly enough to deplete an entire year's public works budget.

#### b. Project implementation

Implementation of the project involves preparation of a plan for each road. The plans will directly address the need by providing the geometry and materials required for each road's physical and drainage characteristics, to result in roads with much higher survivability during monsoonal storms or the average daily storm. The results of the study/plan will be implemented by the town through various means, including implementation of PPRTA projects that will be funded and delivered from 2025 thru 2034. GMF will also be able to utilize the plans recommendations to seek other grant funds as they come available for these much-needed infrastructure improvements. Without this study we won't have the information we need from a qualified engineer to seek necessary funding.

#### c. Does this project address the stated need?

Does this project, as identified in this application, <u>completely</u> address the stated need? If not, please describe additional work or phases and the estimated timeframe. Do you anticipate requesting Energy and Mineral Impact Assistance funds for future phases? (2,500 character limit)

This project as identified will address a vital component of the need. For long term effective road maintenance, three components are needed; a plan for repairing/maintaining each road, permanent public works employees including competent crews and management of crews, and the critical pieces of equipment matched to the types of work regularly being performed. This project will complete the road plans, providing the town with a blueprint of their road system and how to maintain it. Roads issues are a point of contention even outrage between residents, neighbors, and visitors. For example, last summer we had a resident nearly run over a group of children with his vehicle. Children and adults who were residents and visitors from neighboring communities,

on a summer hiking program event. The individual was charged and convicted of menacing, and his minority neighbor who was a young adult testified against him in a court of law regarding her experience. Another example, this summer a motorcyclist injured himself by running over a rut in the road. We have an aging population with ADA accessibility needs. Some of our elderly have reported fear to leave their house to gather groceries and go to doctor's appointment because of fear of getting their car stuck in the road. There is a gentleman who broke his leg in multiple places during a tennis tournament and was restricted to a scooter for some time. He had issues taking his dogs for a walk because of the ruts in the roads. There is a woman who lives at the end of El Paso Trail who has four disabled children, one who is a quadriplegic and restricted to a wheelchair. They have a nurse who comes to care for the children who could not make it up with road in her vehicle and had to park at the base of the road and walk in with her supplies to care for the disabled children. We have 4 garbage companies who provide services in town, who are sometimes not able to collect trash due to road conditions. When they are unable to collect trash, our citizens are understandably outraged and further have concerns about health and safety regarding road conditions. We have had a countless number of trash trucks get stuck on our roads, blocking them, and resulting in tow trucks having to pull them out. Not only will this project reduce contention and even outrage between neighbors , your funding for this project will improve health, safety, social equity, and overall quality of life for GMF residents and visitors.

#### d. What other implementation options have been considered?

The Town is in the process of hiring competent personnel including equipment operators and public works management. The Town has also partnered with El Paso County Procurement and Contracting, and Department of Public Works in an effort to acquire the required equipment through their equipment replacement program.

Without these funds now, the Town will be without plans or guidance on addressing the immediate critical needs and long-term road maintenance needs. Current road needs will require hiring of contractors and will drain the Town's resources/budget.

Providing a plan will greatly increase the efficiency of roadway maintenance reducing the amount of time and funds spent on very expensive contracted projects every time a major storm impacts the roads.

discussions and public events, road conditions the primary concern. Both access and road conditions pose issues at different times of year. While several residents would like to see more paving, others would like the steeper streets to remain unpaved to ensure safer winter driving conditions. 72% of our roads in GMF are unpaved, and 28% are paved. The high pitches/grades on the roads will not allow for many of the roads to be paved. However, a Comprehensive Roads Plan is needed to determine how the town shall care for and improve its roads. The Comprehensive Roads Plan will provide a living working document from a qualified roads engineer outlining what needs to be done to address issues the town is facing in regard to its roads, both immediate and ongoing needs. A complimentary project that is currently in progress we are working on the engineering documents for the construction installation of two large stilling basins to collect sediment at the base of Hotel Street. The project will go to RFP in mid-October, and construction will occur in Spring 2022. The project funding from PPRTA amounts to \$243,290. While this is a step in the right direction, the Town needs a Comprehensive Roads Plan encompassing the entirety of the Towns needs in order to seek further funding to fill that need.

Being located in both Teller County and El Paso County, Green Mountain Falls the connection to mineral impact lies in the need for obtaining gravel for roads, hauling from pits, verifying material needs, and disposing of gravel waste when the roads washout from drainage issues we are currently facing. This Comprehensive Roads Plan will provide Green Mountain Falls with a plan to address road waste that washes into Fountain Creek and impacts the creek bed.

The PPRTA November 2022 ballot measures, will go into the PPRTA 2025-2034 transportation improvements plan for the entire region. If this project is not funded, another opportunity to positively impact the road conditions in this capacity won't come along again for more than a decade. GMF has heavy truck traffic that drastically impacts the road conditions. We currently have 4 trash companies driving our roads weekly, the impact one-way is 9,300 times greater than that of a regular size SUV. The community plans to work on a single hauler trash study; if implemented, that will drastically reduce the amount of wear and tear on our public roads. This impact does diminish the quality of our roads and increases the drainage issues we are facing. A 2017 local traffic counts study showed 13,115 traverses of two-way vehicles at one of the two entry points to GMF over a two-day weekend period. That is an extraordinary amount of use for such a small town, and likely largely due to our proximity to Colorado Springs, and our beautiful natural resources and interest in our hiking trail system. This Comprehensive Roads Plan, and guiding working document, will help us learn how we need to improve and maintain our roads for a better future in GMF. Creating a plan for improvements that will help us protect the environmental/mineral impacts the Town has on our beautiful environment. With this plan, going forward we will better be able to manage the stormwater runoff that is conveyed wholly by the roads downstream to discharge into drainageways tributary to Catamount Creek, or Fountain Creek via the Gazebo Lake.

We also intend to take the results from this study that our staff may not have the ability to complete in house and include those recommendations for improvement with our PPRTA November 2022 ballot measures that are due from the Town to PPRTA in the first half of 2022. If the measure passes the proposed improvements would be funded through the PPRTA, and would be included in their transportation improvements 2025-2035 plan, work that would be completed by a qualified 3rd party contactor. GMF can submit approximately \$800k to \$1million of an recommended improvements to be included on the ballot measure. Additionally, we will have on-going annual maintenance dollars from the PPRTA to help with maintaining what is implemented via this plan.

The third-party that completes this Comprehensive Roads Plan will be experienced in specifically roads engineering, stormwater drainage, and will have extensive experience working in the types of conditions that present in the Town of Green Mountain Falls.

We essentially are in a mountain ditch-like terrain with high pitched gravel roads and, have all of the drainage issues that come along with our terrain.

Neither Counties have the capacity to take on or assist roads improvements or maintenance in GMF, or a Comprehensive Roads Plan.

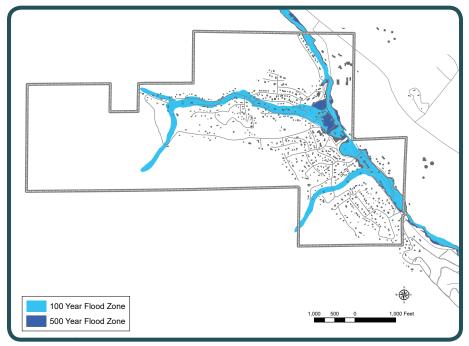
### HAZARDS

The hazards of living in a small mountain town with steep slopes include wildfires, such as the 2012 Waldo Canyon Fire, as well as floods. According to some community members, development upstream and more frequent microburst storm events have caused a significant increase in flooding in recent years. Increases in flooding directly correlate to a greater chance of landslides, especially on south-facing slopes with sparse vegetation.

Approximately 18% of structures in the Town are located within the 100-year flood zone (FEMA 2018). **Figure 6** presents FEMA flood zones data for the 100- and 500-year flood zones.

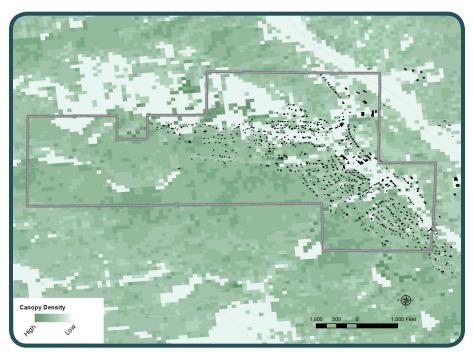


FIGURE 7. TREE CANOPY DENSITY Source: USGS Canopy Data and Tree Canopy Data

Additionally, fire suppression over time has created a very dense forest canopy within the Town and adjacent areas. Under current conditions, there are several more trees per acre than in previously recorded historic measurements. The **Figure 7** illustrates current canopy density within the Town and surrounding areas.

To further illustrate how the forest has become denser over time, images from the 1900s are compared with current photography on the following page.



**FIGURE 6. FLOOD ZONE** Source: FEMA Floodplain Data, December 2018

We are Mike and Margaret Frey. We own three cabins on Falls Ave. in GMF, CO and a store on Ute Pass Ave. (Painted Bear arts and crafts store)

We agree with many you have heard from, that GMF is in critical need of creating a comprehensive roadway and drainage plan that will lead to proper drainage of the roadways in GMF. Many of the roads are up and down hills (some very steep) and, with an inadequate ditch and culvert system, the rain runs down the middle of the road instead of into a ditch, roads wash out and severe ruts are formed. After each rain, many of the the roads are unsafe to travel.

Our three cabins on Falls Ave are at the end of the road on a cul de sac and the entrance to the cul de sac is up a steep hill. This year the heavy rains have destroyed our road, like many others in GMF. We literally had ruts a foot deep in the middle of the road leading into our cul de sac!! A small car could not make it into our cabins. We rent two of our cabins on VRBO to guests from all parts of the country. Some of them come in small cars without 4-wheel drive. Without our truck, with 4-wheel drive, we could not have made it to our cabin.

A comprehensive plan that addresses roadway maintenance in the town is essential. We need ditches and culverts that can handle the rains and snow runoff. Our road maintenance crew needs to be able to crown the roads so that water runs off into ditches and under roads in culverts rather than having water run down the roads and form gigantic ruts!!!.

After the last big rain, I came across a small car trying to turn off of Hondo into a driveway. The car was high centered with a rear wheel in a huge rut. The driver could not move forward or backward! I offered to hook on to the car with my 4-wheel drive truck and pull him out of the rut when 5 hikers came by. The 6 of us were able to push the car out of the rut and into the driveway, but I have no idea if, or how, he got back out of the driveway!

Having improved roadways with better drainage is critical for the safety and long-term prosperity of the town, and the plan that will be funded by this grant is a necessary step in making that happen.
