Regular Meeting:

1. Call to Order/Roll Call/Pledge of Allegiance

Meeting called to order at 7 pm.

2. Additions, Deletions, or Corrections to the Agenda

Vice Chair Ochkie requested additions that included, Member Gafford's recommended park names and dangerous ice flows on Catamount Trail.

Member Stroope moved to add the items to the agenda. Seconded by Member Gafford. Motion passed unanimously.

3. Persons Present Not on the Agenda: 3 Minutes per Speaker

Resident Bratton had requested to speak but was not available. Vice Chair Ochkie expressed that should Resident Bratton join the meeting later, that he could share his comments.

Member Gafford requested that Town Clerk/Treasurer Gordon complete and upload the meeting minutes a week before meetings.

4. Consent Agenda

Member Stroope moved to approve. Seconded by Member Gafford. Motion passed unanimously.

5. Old Business

Vice Chair Ochkie opened the discussion with a focus on setting consistent meeting dates and times. Member Stroope and Member Gafford expressed that they were open schedule wise. Member Stroope recommended moving the meetings from 7pm to 3pm and to hold 2nd meetings on the 3rd Wednesday of each month. Vice Chair Ochkie, Member Gafford, and Town Clerk/Treasurer Gordon expressed desire to change the meeting date. Motion to accept the new

meeting dates and times tabled for another meeting. Discussion continued and members agreed to hold their next meeting on the 3rd Wednesday at 3pm.

6. New Business

Vice Chair Ochkie made a motion to elect Matt Gordon as Secretary. Seconded by Member Gafford. Motion passed unanimously.

Vice Chair Ochkie tabled the discussion on Bike Parts for Tots and Park names for the next meeting.

Vice Chair Ochkie went on to open the discussion regarding ice flows on Catamount Trail. Vice Chair Ochkie made recommendations to place ice flow awareness signage on the bottom of Hondo and Belvedere. Member Stroope shared agreement that the ice flows are a safety risk and recommended that the BOT place signage, potentially close that section of the trail, and to contact Colorado Springs Utilities.

Discussion continued regarding the ice flows on Catamount Trail. Vice Chair Ochkie shared that she communicated with Town Manager Sprang regarding the ice flows. Vice Chair Ochkie went on to ask how the PRT could make recommendations to the BOT. Town Clerk/Treasurer Gordon detailed the process for that.

Member Stroope moved to close sections of Catamount Trail and to contact Colorado Springs Utilities for mitigation and to make a formal recommendation to the BOT. Seconded by Member Gafford. Motion passed unanimously.

7. Correspondence

None.

8. Reports

Member Stroope reported on multiple estimates he gathered. Those estimates included goose repellent for \$309 for a 2.5-gallon container, a backflow preventer at Flagpole Park for \$1500 with the disclaimer that other costs may arise due to irrigation system issues, and lastly tree removal for a large tree by Gazebo Lake for \$1260.

Vice Chair Ochkie moved to support recommending to the Town Public Works to purchase goose repellent. Seconded by Member Gafford. Motion passed unanimously.

Vice Chair Ochkie moved to recommend a backflow preventer at Flagpole Park to the BOT. Seconded by Member Gafford. Motion passed unanimously.

Vice Chair Ochkie tabled the discussion, at Member Stroope's request, on tree removal for a future meeting.

Resident Bratton arrived at the meeting and shared public comment on agenda item 5.

Trustee Loo requested that future meeting agendas include discussion related to the Trail Ambassador Program. Vice Ochkie confirmed that that topic will be a focus in the future.

Town Clerk/Treasurer Gordon detailed the requirements related to attendance for PRT Committee members and that if members miss three meetings they can be removed from the Committee. Discussion continued on potential Chair's for the committee and well wishes for the current Chair, Chair Goodwin.

9. CIRSA Annual Training Video

Members intently watched the CIRSA Annual Training Video.

Avian Migrate is a product that the town used a few years ago for goose abatement at the park. This was applied through a vendor who was quite expensive. The product is available on Amazon for \$309/2.5 gallon. Based on our usage at Green Box, I would estimate that Gazebo Park could be treated for the summer months with one container of this product being applied by town maintenance staff. The product does not hurt the geese and is safe for turf and water (lake).

The backflow preventor is required to have the meter reinstalled at the park in order to run the irrigation system there. This quote is only for the backflow assembly and would not cover additional repairs that are likely required to the irrigation system.

We are seeking funding for Phase I of a larger project to provide universal accessibility to all Green Mountain Falls parks. Phase I focuses on our most popular and iconic space, Gazebo Lake Park. Funds are being sought to build an accessible fishing pier, an ADA compliant concrete pathway that connects the pier to the handicap parking spaces at the north and south ends of the park, and inclusive playground equipment. Currently, anyone with accessibility challenges has very limited access to public fishing at the lake, the playground and the park in general. For those who use wheelchairs, that accessibility is nearly zero.

We are seeking funding for Phase I of Access for All, a project to create inclusive public park areas for the recrea on of people of all ages and abiliĀes in Green Mountain Falls, CO. Through several phases, the exis ng parks will be upgraded for accessibility and everyone's safety. In addiĀon, Access for All will create more inviĀng year-round mulĀ-use spaces for the enjoyment of our residents and visitors. Gazebo Lake Park anchors our town and its natural beauty draws visitors from surrounding areas and beyond. Annual events, like Bronc Day, that take place in Gazebo Lake Park will be accessible to parĀcipants of all ages and abiliĀes with the addiĀon of the ADA complaint pathway. The proximity of Green Mountain Falls and Gazebo Lake Park to the city of Colorado Springs makes it a popular choice for individual and family ouĀngs, senior day trips, and a place to relax and rejuvenate for acĀve and re red military alike.

Phase I: Gazebo Lake Park

a) Install an ADA compliant concrete pathway from the parking areas at the north and south end of Gazebo Lake connecng to a fishing pier.

b) Install an accessible fishing pier on the south end of Gazebo Lake.

c) Install outlet stream to provide inclusive access to moving water for pleasure and play.

d) Install inclusive playground equipment at the Gazebo Lake Park playground.

Phase II: Gazebo Lake Park

a) Reinforce the hillside next to the proposed pathway with rocks and landscaping on the west side of Gazebo Lake Park.

b) Install an ADA compliant pathway that circumnavigates Gazebo Lake.

Phase III: Municipal Pool

a) Install ramp for wheelchair and walker accessibility.

b) Install 2 ADA compliant toilets and showers.

c) Install a poolside li. .

Phase IV: Northwest Park

- a) Install an ADA complaint pathway from the pool parking lot to swings, basketball court and tennis court.
- b) Install inclusive playground equip children from 7 years of age and up.
- c) Install tricycle and bicycle area for early learners.

Green Mountain Falls is located in a beau ful natural environment and all residents need to have access to our parks. We are dedicated to facilita Ing accessibility to everyone in the community. This includes the members of a small group home for physically challenged children (approximately 6), as well as an aging popula on with changing abili es. We feel strongly that everyone should have opportuni es to enjoy the outdoors, to play together, and to engage with nature.

Fishing is a tradi onal pas[®]me at Gazebo Lake. Fishing is [®] meless and ageless and well known for its therapeu c value.

In addi on to the residents, we have visitors that come from all over the world — we want everyone to feel welcome and able to access our parks.

What are the quan[®] fiable goals of this project? How will they be measured? (*Example: Build 10 low-income rental units, provide healthcare for 100 low-income residents*)

A part- me public works employee told a story of a Ime when he was in a near-fatal car accident. When he was recovering at Craig Hospital, his mother was allowed to take him in his wheelchair to a nearby lake for some therapeu c fishing. He said the feeling of being outside, doing something he loved — feeling like part of his former world again— was wonderful. He is so intrigued with this project that he contributed his Ime and energy for the sketch that is aImeded. It is difficult to quanIfy the therapeu c value described here, but this project will bring that joy to others. GMF will request a consultaIm or responses from The Resource Exchange or Cheyenne Village for feedback during the design process to ensure the upgrades are aImed to the needs of persons with disabili es. We have aImeded photos of the areas in need of improvement.

The concrete pathway will allow everyone to access Gazebo Lake Park and the pleasures of fishing without worrying about accessibility, traffic dangers or uneven ground.




