1. Call to Order/Roll Call/Pledge of Allegiance

Member Battin provided a quick update on his work related to fuels mitigation. Members engaged in a brief discussion on potential master planning for fuels mitigation. Resident Blasi shared a presentation regarding fire mitigation work completed in 2020 and nuisance trees in

Town. Members then engaged in discussion on the processes and plans for mitigating nuisance trees in Town.

Member Esch provided an update regarding grant opportunities for the Town.
