**Regular Meeting:**

**1. Call to Order/Roll Call/Pledge of Allegiance**

Meeting called to order at 3:01 pm.

**2. Additions, Deletions, or Corrections to the Agenda**

**3. Persons Present Not on the Agenda: 3 Minutes per Speaker**

Resident Eddy shared public comment regarding Agenda Item 5a: Trail Maps. Resident

**4. Consent Agenda**

Member Gafford moved to approve the Consent Agenda. Seconded by Member Ochkie. Motion passed unanimously.

**5. Old Business**

Vice Chair Kita shared an update from the BOT meeting held on 4/6 where the Board provided guidance on how to move forward with creating trail maps. Members then discussed their opinions regarding the guidance from the BOT as well as how to move forward in creating trail maps, trail signage, and establishing trailheads.

Vice Chair Kita screen shared a working copy version of a potential trail map for the Town. Members provided comments and direction on the draft trails map to Vice Chair Kita. Members agreed to have Vice Chair Kita continue working on the Town's trails map and that Members would provide comments to Vice Chair Kita via email.

Members then transitioned discussion to Member Gafford's trail head drawing and establishing a virtual trailhead. Chair Stroope suggested renovating bathrooms at Pool Park and to establish a virtual trailhead near Pool Park. Chair Stroope requested to continue addressing Agenda Item #5b at a future PRT Committee meeting. Members agreed.

Trail Ambassador Volunteer Coordinator (TAVC) Dixon shared an update on the Trail Ambassador program for 2021.

**6. New Business**

TAVC Dixon shared a draft of the “Hiker Five”, a series of five rules created by Dixon to communicate to hikers the expectations of behavior on Town trails. Members expressed positive sentiment regarding the Hiker Five. Chair Stroope requested to continue the Hiker Five discussion for the next PRT Committee meeting. Members agreed.

Members transitioned to discussion regarding The Great American Cleanup. Vice Chair Kita provided an update on the plans for the Town’s contribution to The Great American Cleanup, sharing that the Town had missed the deadline to formally signup, but that the Town could participate informally.

Chair Stroope moved to have Members Gafford and Kita create a plan for The Great American Cleanup on 4/24. Seconded by Member Ochkie. Motion passed unanimously.

Members then moved to discussions on gopher control in Town. Town Clerk/Treasurer Gordon suggested sharing gopher control information with him to pass on to Public Works. Members agreed.
