## 1. CALL TO ORDER / ROLL CALL

Parks, Recreation, and Trails meeting called to order at 4:00pm by Chair Stroope.

## 5. OLD BUSINESS

- a. Walker presented his updated, detailed cost analysis report on the dumpster blind construction that included four options to defray the overage of \$9520. McIntire said that the PRT meeting time/day was doable. Dixon moved to recommend to the Board that Philip McIntire fill the PRT vacancy. Walker

Chair Stroope reported he is looking into options for an ADT reroute. He will be reaching out to Friends of Ute Pass Trails.

Kita said he is working with town staff to set up dates for community meetings on the revisioning of the stilling basin area.

Walker asked about the pool and if the PRT could obtain budgetary information to make recommendations to the Board for reopening. Dixon mentioned that UCCS is doing an asset study of the pool but PRT has not been involved with this effort. Chair Stroope said a formal feasibility study leads to more grant opportunities. Walker thought an operational study done by PRT could help. Mayor Dixon said he will bring up a request at the Board meeting to ask the PRT to do this study.
