1. Call to Order/Roll Call/Pledge of Allegiance

Mayor Dixon called the meeting to order at 7:01 p.m. The Pledge of Allegiance was recited. All Board members were present except for Trustee King.

2. Additions, Deletions, or Corrections to the Agenda

Trustee Guthrie made a motion, seconded by Trustee Donzello, to accept the agenda as amended. Motion passed unanimously. The changes were to table items 5D, 5K 7 5L.

3. Public Comment

Margaret Peterson presented regarding the need for temporary signage around the Church in the Wildwood for regular services and special events. The request was approved administratively.

4. Consent Agenda

Trustee Donzello motioned to approve the minutes from 2023-04-04. Trustee Guthrie seconded the motion which passed unanimously.

5. Business

- 5A) Lisa Huizenga FMAC Application. Lisa's application was approved by FMAC unanimously. A motion by Trustee Donzello was seconded by Trustee Guthrie and the motion passed unanimously.
- 5B) PC Recommendations to BoT. The Planning Commission made several recommendations to The BoT in the form of a memo. BoT decided to accept the recommendations with modifications.
- 5C) Ordinance 2023-02 LU/Muni Code Conflict. Mayor Dixon performed the first reading of Ordinance 2023-02. Adoption of their Ordinance would clean up the parts of the Land Use

Code and Municipal Code regarding the number of horses per parcel, the fence set back and the use of an Animal Shelter in the new Open Space Zoning. Trustee Donzello motioned to approve as amended and Trustee Ives seconded. The motion passed unanimously.

A motion to approve the removal of the trees was made by Trustee Guthrie and seconded by Trustee Donzello which passed unanimously.
- 5I) Fitness Court Shade Sail. PRTAC and Planning Commission both approved a Historic Green Mountain Falls Foundation donation to the town for shade sails. The shade Sails will be placed over the Fitness Court. A motion to approve was made by Trustee Guthrie and seconded by Trustee Donzello. The motion passed unanimously.

ORDINANCE NO. 2023-02

AN ORDINANCE AMENDING CHAPTERS 6 AND 12 OF THE GREEN MOUNTAIN FALLS MUNICIPAL CODE REGARDING THE REGULATION OF HORSES

WHEREAS, the Town wishes to modify the regulation of horses especially as it relates to horses in the Open Space district.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF GREEN MOUNTAIN FALLS, COLORADO:

<u>Section 1</u>. Chapter 6 Article VI Section 6-78 of the Town of Green Mountain Falls Municipal Code is hereby amended to read as follows:

Sec. 6-78. – Limit on number of animals.

- (a) It is unlawful for any resident in the town to have more than the following number of each type of pet unless the residence is licensed as a kennel pursuant to this Code, or unless the maximum number is exceeded by pets of less than six months of age:
 - (1) Dogs: two.
 - (2) Cats: four.
 - (3) Rabbits: six.
 - (4) Pot-bellied pigs: three.
 - (5) Ferrets: three.
 - (6) Reptiles (nonexotic): four.
 - (7) Horses: As permitted by Section 6-122 of the Green Mountain Falls Municipal Code
- (b) It is unlawful to keep, own, harbor or allow to run free any exotic animal or any livestock of a type not listed above within the Town.
- (c) Notwithstanding any other provision of the Green Mountain Falls Municipal Code, use of animals otherwise prohibited may be allowed by special use permit from the town pursuant to section 16-710 for commercial purposes, subject to such conditions and restrictions as may be imposed by the board of trustees.
- Section 2. Chapter 6 Article VI of the Town of Green Mountain Falls Municipal Code is hereby amended to read as follows:

ARTICLE VI. – Horses

Sec. 6-121. – Property size requirements.

Horses shall only be permitted on property with a lot size of two-and-one-half acres or more and as permitted in Table 3-1 of Chapter 12 Article III of the Town of Green Mountain Falls Municipal Code. Horses shall be kept in a fenced area setback a minimum of ten feet from all property except for horses in the Open Space district or any horse with a permit issued prior to the original passage of this article (April 1996).

Sec. 6-122. – Enclosures.

Horses shall be kept in a suitable fenced enclosure, in which said animals shall be restrained, providing a minimum area of 1,500 square feet per animal. Said enclosure shall be located a minimum distance of 75 feet from any neighboring house, dwelling or place of business.

Sec. 6-123. - Permit required; fee.

A permit shall be required for an individual household to keep horses within the town. Upon receiving an application for said permit, the town shall request an animal control officer to inspect the proposed premises to determine if the requirements provided in this article are satisfied by the applicant. If said requirements are satisfied, a permit shall be issued for one calendar year, expiring on January 31 st of each year, for which a fee as established by resolution of the board of trustees shall be charged. The permit is not transferable and shall be issued only for the horse listed in the application procedure. If, at any time the premises upon which horses are kept fail to satisfy the requirements of this article, said permit may be revoked by the board of trustees.

Section 3. Table 3-1 in Chapter 12 Article III of the Town of Green Mountain Falls Municipal Code is hereby amended by the addition of the following new Horse Keeping use to read as follows:

Section 4. Chapter 12 Article VI of the Town of Green Mountain Falls Municipal Code is hereby amended by the modification of the Animal Shelter definition and the addition of a Horse Keeping definition to be inserted alphabetically and to read as follows:

ANIMAL SHELTER

A facility that is operated for the purpose of providing for and promoting the welfare, protection, and humane treatment of animals, that is used to shelter at least 10 animals in a year, and that is operated by a government entity, humane society, animal welfare society, animal rescue group, or other nonprofit group.

HORSE KEEPING

The keeping of horses as a customary, incidental, and accessory use to a Single-Family Detached Dwelling and meeting the applicable requirements of Chapter 6 Article VI of the Green Mountain Falls Municipal Code.

<u>Section 5</u>. <u>Severability</u>. If any section, paragraph, clause, or provision of this Ordinance shall for any reason be held to be invalid or unenforceable, the invalidity or enforceability of such section, paragraph, clause or provision shall not affect any of the remaining provisions of this Ordinance, the intent being that the same are severable.

<u>Section 6</u>. <u>Safety</u>. The Board of Trustees finds that the adoption of this Ordinance is necessary for the protection of health, safety and welfare of the public.

<u>Section 7</u>. <u>Effective Date</u>. This Ordinance shall become effective after final approval and adoption on second reading.

Background

At their 6.14.2023 meeting, PRT unanimously voted to recommend to the Board to accept a Kirkpatrick Family Fund grant.

Discussion

The Kirkpatrick Family Fund has generously offered a grant to the town of GMF in the amount of \$42,500 to be spent on the following items: \$20,000 for the emergency painting of the Gazebo, \$14,500 to replace the playground mulch in both Pool Park and Gazebo Park and \$7,500 to replace the Gazebo Lake fountain.

To prevent further degradation of the Gazebo, the town's brand, painting of the Gazebo is desperately needed. The playground mulch in both parks has been tagged as a CIRSA safety item and needs to be releveled and replaced.

The Gazebo Lake fountain has not been operational due to a burned out motor.

Recommended Motion

I move to accept the grant from the Kirkpatrick Family Fund to be used on painting the Gazebo, replacing the playground mulch and getting a new Gazebo Lake fountain.

RESOLUTION OF THE BOARD OF DIRECTORS OF PIKES PEAK RURAL TRANSPORTATION AUTHORITY REGARDING THE REQUEST BY THE CITY OF FOUNTAIN TO JOIN THE PIKES PEAK RURAL TRANSPORTATION AUTHORITY

At a regular meeting of the Board of Directors of the Pikes Peak Rural Transportation Authority, held at 1:30 P.M., on Wednesday, June 14, 2023, at the PPACG Lower-Level Conference Room at 15 S. 7th Street, Colorado Springs, Colorado 80905 and https://ppacg.zoom.us/j/95524861427?pwd=dFhRWEhKbzdLbmluSC9GQXhCSGM3Zz09 Dial-in Number: +1 346 248 7799, Meeting ID: 955 2486 1427, Passcode: 981112, at which a quorum was present, the following resolution was adopted:

WHEREAS, Pikes Peak Rural Transportation Authority (the "PPRTA") is a political subdivision and body corporate of the State of Colorado organized pursuant to the Regional Transportation Authority Act, Part 6 of Article 4 of Title 43, C.R.S, (the "Act") after approval of the registered electors of the PPRTA and issuance of a certificate by the director of the division of local government in the department of local affairs; and

WHEREAS, the PPRTA is governed by the Fifth Amended and Restated Intergovernmental Agreement Among El Paso County, Colorado, the City of Colorado Springs, the City of Manitou Springs, the Town of Green Mountain Falls, the Town of Ramah, and the Town of Calhan For Creation of the Pikes Peak Rural Transportation Authority (the "Establishing IGA"); and

WHEREAS, the Establishing IGA and C.R.S. §§ 43-4-603(1)(h) and 43-4-605(2) control how new territory and participants members may be added to the PPRTA; and

WHEREAS, the City of Fountain adopted Resolution 23-023 on May 23, 2023, attached hereto as **Exhibit A** and incorporated herein by this reference (the "Fountain Resolution"); and

WHEREAS, the Fountain Resolution, among other things, (1) affirms in accordance with Section 12.1 of the Establishing IGA that the City is a municipality as defined by § 31-1-101(6), C.R.S that may request to become a party to the Establishing IGA and a member of the PPRTA, (2) requests in accordance with Section 12.2 of the Establishing IGA, that the City to be added as a new member of the PPRTA, a party to the Establishing IGA, and seeking inclusion of the territory within the City limits into the boundaries of the PPRTA, and (3) consents in accordance with C.R.S. § 43-

4-605(2)(a) to the inclusion of the territory within the City limits being included into the boundaries of the PPRTA; and

WHEREAS, the Fountain Resolution also requested confirmation from the Board of Directors of the PPRTA that it intends to cooperate in the addition of the City as a new member of the PPRTA, a party to the Establishing IGA, and to have the territory within the City limits included into the boundaries of the PPRTA; and

WHEREAS, the Board of Directors of the PPRTA (the "PPRTA Board") wishes to express its present intention regarding the City's request and refer the matter for consideration to the existing parties to the Establishing IGA;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE PIKES PEAK RURAL TRANSPORTATION AUTHORITY THAT:

- 1. The PPRTA Board hereby acknowledges receipt of the Fountain Resolution in satisfaction of Section 12.1 of its Establishing IGA and partial satisfaction of Section 12.2 of its Establishing IGA.
- 2. The PPRTA Board recognizes that Section 12.2 requires that prior to the City being added as a party to the Establishing IGA and its corporate boundaries being added to the territory of the Authority, the City shall place the matter of joining the PPRTA on the ballot at any general or special election for approval of a majority of the voters residing in its boundaries. As such, any formal determination by the PPRTA Board regarding addition of the City as a party the Establishing IGA and/or inclusion of its territory into the boundaries of the PPRTA will be subject to prior receipt of certification from the City that it has fulfilled all legal requirements related to such addition and inclusion and that a majority of the voters residing in its boundaries have voted in favor thereof at a general or special election held by the City in accordance with all applicable laws.
- 3. The PPRTA Board further recognizes that Section 12.3 of its Establishing IGA requires that the City may only become a party to the Establishing IGA if the current parties to the Establishing IGA unanimously consent to such addition of a new party as determined by a majority vote of the governing bodies of each existing party. As such, the PPRTA Board hereby refers to the governing bodies of El Paso County, Colorado, the City of Colorado Springs, the City of Manitou Springs, the Town of Green Mountain Falls, the Town of Ramah, and the Town of Calhan for consideration of the matter of adding the City as a party to the Establishing IGA and requests that each governing body take action on such matter on or before August 2, 2023.
- 4. The PPRTA Board hereby confirms that its present intent is to cooperate in the addition of the City as a new member of the PPRTA, a party to the Establishing IGA, and to have the territory within the City limits included into the boundaries of the PPRTA, subject to City's receipt of voter approval by a majority vote regarding such matters, provided that all legal requirements therefore are met, and provided the necessary unanimous consent from all of the present parties to the Establishing IGA is obtained.

- 5. All actions not inconsistent with the provisions of this Resolution heretofore taken by the members of the Board and the officers, agents and employees of the PPRTA and directed toward the purposes stated herein are hereby ratified, approved and confirmed.
- 6. If any section, paragraph, clause or provision of this Resolution shall be adjudged to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining sections, paragraphs, clauses or provisions of this Resolution, it being the intention that the various parts hereof are severable.
 - 7. This Resolution shall take effect on the date and at the time of its adoption.

WHEREUPON, a motion was made and seconded, and upon a majority vote this Resolution was approved by the Board.

A RESOLUTION REQUESTING INCLUSION INTO THE PIKES PEAK RURAL TRANSPORTATION AUTHORITY

WHEREAS, the City of Fountain (the "City") desires to join the Pikes Peak Rural Transportation Authority (the "PPRTA"), a regional transportation authority organized pursuant to C.R.S. § 43-4-601, et seq.;

WHEREAS, the PPRTA is governed by the Fifth Amended and Restated Intergovernmental Agreement Among El Paso County, Colorado, the City of Colorado Springs, the City of Manitou Springs, the Town of Green Mountain Falls, the Town of Ramah, and the Town of Calhan For Creation of the Pikes Peak Rural Transportation Authority (the "Establishing IGA");

WHEREAS, the Establishing IGA and C.R.S. §§ 43-4-603(1)(h) and 43-4-605(2) control how new territory and members may be added to the PPRTA;

WHEREAS, before the City can be added to the PPRTA, voters within the City will need to approve the City becoming a member of the PPRTA, including the territory within the City limits within the boundaries of PPRTA, and imposing the PPRTA sales and use tax within the City;

WHEREAS, if approved by the PPRTA members, the City expects to place a ballot question on the ballot at the Colorado Coordinated Election on November 7, 2023;

WHEREAS, also before the City can be added to the PPRTA, the Establishing IGA may need to be amended to include the City as a party; and

WHEREAS, the City desires to take the preliminary step of requesting being added as a party to the Establishing IGA and having its territory included into the PPRTA boundaries.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Fountain, Colorado, as follows:

<u>Section 1.</u> In accordance with Sections 12.1 and 12.2 of the Establishing IGA, the City hereby states that it is a municipality as defined by C.R.S. § 31-1-101(6) and formally requests to be added as a new member of the PPRTA, a party to the Establishing IGA, and to have the territory within the City limits included into the boundaries of the PPRTA.

Section 2. In accordance with C.R.S. § 43-4-605(2)(a) the City Council hereby consents to the inclusion of the territory within the City limits being included into the boundaries of the PPRTA.

Section 3. If determined necessary by the Board of Directors of the PPRTA or one of the current parties to the Establishing IGA, the City hereby requests an amendment to the Establishing IGA to effectuate its addition as a party to the Establishing IGA and member of the PPRTA.

Section 4. The City Council further requests confirmation from the Board of Directors of the PPRTA that it intends to cooperate in the addition of the City as a new member of the PPRTA, a party to the Establishing IGA, and to have the territory within the City limits included into the boundaries of the PPRTA, subject to City voter approval and provided that all legal requirements therefore are met and provided the necessary unanimous consent from all of the present members of the PPRTA is obtained as required by Section 12.3 of the Establishing IGA.

Section 5. The Mayor and City staff are hereby authorized to take such additional steps as may be necessary to pursue addition of the City as a new member of the PPRTA, a party to the Establishing IGA, and to have the territory within the City limits included into the boundaries of the PPRTA.
